Basic Dog Manners To Be Followed Inside Superior Dog Training Center

- ❖ Unless otherwise instructed, keep a 3 foot distance between dogs. Please refrain from allowing your dog to approach other dogs. Exceptions may be made by your instructor.

- ❖ Please be aware of what your dog is doing at all times. If your dog stares, lunges or barks at other dogs or people, redirect your dog.

- ❖ Dogs who demonstrate any of the following aggressive behaviors may be excused from class and referred to another trainer or behaviorist for help before returning to class,
 - a. repeated growling, snarling, lunging, biting or snapping at other dogs or humans
 - b. involvement in a dog or human attack (other than the owner).

- ❖ All Superior Dog Training instructors have the right and responsibility to excuse any dog and handler from class if the instructor feels the dog poses a threat to the safety of the other dogs and/or handlers.
